I believe our fall conference has the potential to be a uniquely excellent opportunity to see a "bigger picture" of the happenings in environmental health at this regional level and to network with environmental health specialists and industry leaders from areas outside of Virginia. We hope you all will be able to take advantage of this special fall conference opportunity!

The board is equally excited to offer more CEU's and networking this spring with our virtual Onsite and Food Safety Education Days. The Spring 2021 program is being proposed as a historical review of the early alternative onsite sewage disposal system products to where we are today. The idea is a panel, or "Open Mike" opportunity, for ethnic restaurant owners to discuss the challenges they have preparing their dishes and/or running a restaurant while meeting regulatory requirements. If you have an ethnic restaurant in your responsibility area, ask if they would like to participate in our Zoom educational conference. The idea would be to convey information they found challenging as an ethnic restaurant owner under our regulations and policies and how the challenges were resolved. Having regulators and customers on the same page would go a long way to bringing success on both sides of the isle. Some areas of the state have a concentration of ethnic communities that may be migrating to other cities, so let's be prepared to make a smooth transition for those coming changes and hear from established restaurant owners. I hope meeting via Zoom would not significantly impact daily operation of their facility.

This scholarship is currently funded at \$500.00 and is awarded to the most qualified applicant(s) at the Spring Educational Conference. Application deadline is March 31. Certificates of Merit: Every NEHA state affiliate is invited to designate an individual and/or a team of its members to receive a Certificate of Merit, thereby nationally recognizing one of their own for outstanding contributions to the profession of environmental health. Recipients are recognized during NEHA's Annual Education Conference awards program and in the Journal of Environmental Health. This is an opportunity for

special recognition of one of our own members in front of a national audience. **Nominations must be received by May 30.** To apply, visit [VEHA's Scholarships-Awards page](#).

Environmental Health Professional of the Year: The nominee for the Environmental Health (EH) Professional of the Year award must be an EH Professional currently engaged in the practice of Environmental Health who has made outstanding contributions to the EH Profession, and the EH Programs in the Commonwealth of Virginia. Nominees must be current VEHA members and should exemplify the values, quality of work, and ethical integrity held in high regard by the EH profession. Sponsors who make the nomination must also be current VEHA members. This award is presented each year at VEHA's Fall Educational Conference. **To nominate a deserving EH Professional, submit your nomination form by September 30.** The nomination form can be found on [VEHA's Scholarships-Awards page](#).

A. Clark Slaymaker Award: A. Clark Slaymaker was a Virginia Department of Health employee from 1943 to 1970. He ended his career as the EH Manager (then called Chief Sanitarian) in Alexandria, Virginia. In 1966 he won NEHA's prestigious Walter S. Mangold award, the **ONLY** VDH employee ever to do so. This award was created to recognize an individual, association, corporation, or organization that is not actively engaged in the field of environmental health but has made outstanding contributions and supported the EH Profession and the EH programs in VA. The individual(s) who wish to submit a nomination for this award must be a current member of VEHA however, it is not necessary for the nominee to be a member. **The deadline for nomination is September 30.** The nomination form can be found on [VEHA's Scholarships-Awards page](#).
